BIRTH REGISTRATION



The birth registration in the province of Ifugao for 2022 totaled to 4,138 with 64.35% timely registered. By sex aggregation, more male babies (50.39%) were born in 2022. Lamut registered most of the birth that occurred with 27.62% from the total birth registration. The municipality of Hingyon registered the least number of births with 0.74%.

For the registration process, more births in Lagawe (28.89%) were registered late for the 30-day reglementary period given to register a birth, which is considered a vital event.



Figure 1: Birth Registration by Sex, Ifugao 2022

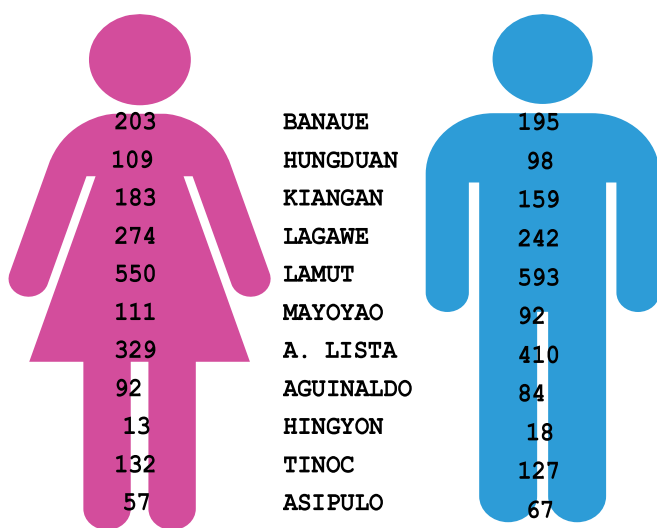


Figure 2: Birth Registration, Ifugao: 2022

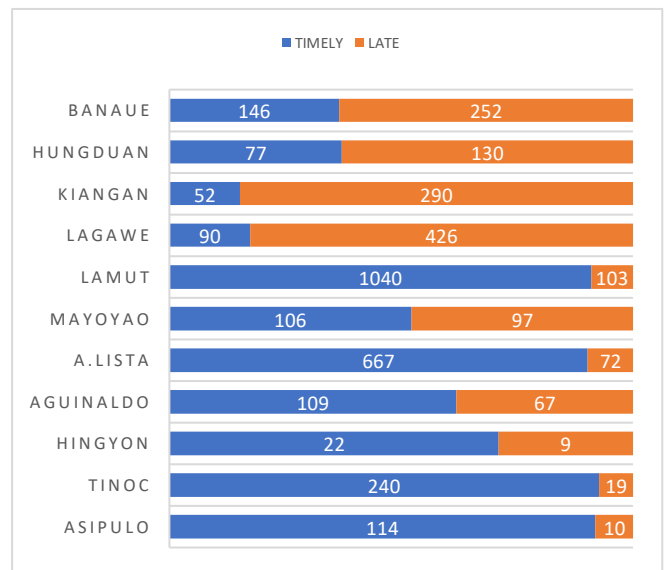


Figure 3: Birth Registration by Legitimacy, Ifugao: 2022

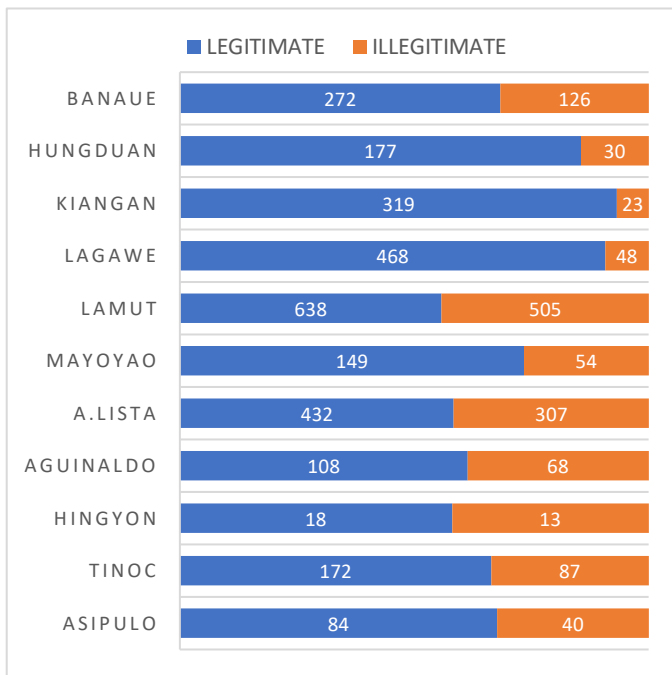
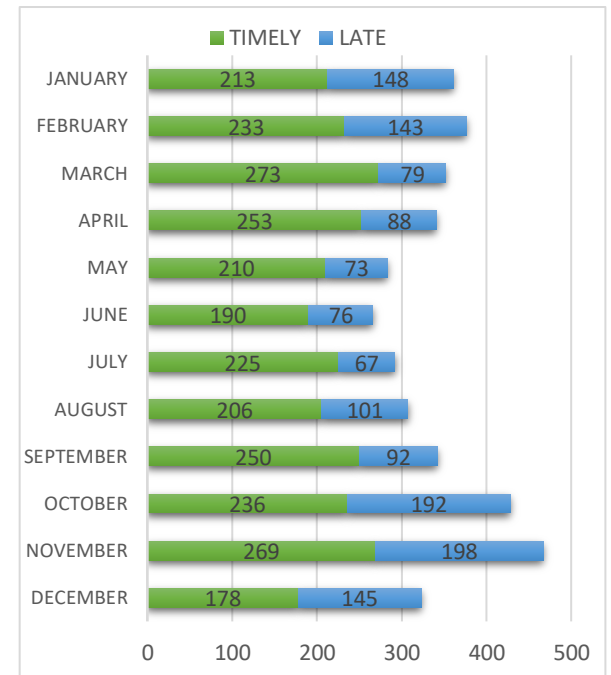


Figure 4: Birth registration by Registration and by Month: Ifugao, 2022



For the legitimation, Lamut has the greatest number of legitimate births at 15% and the greatest number of illegitimate births at 12%. The month of November recorded the most registered births for the whole year.

MARRIAGE REGISTRATION



For 2022, the province of Ifugao recorded 1,081 registered marriages. Alfonso Lista recorded most of the marriages in the province at 17.4% followed by Lamut at 12.9% then Aguineldo at 11.7%. The least registered marriage occurred in Hingyon at 4.3%.

Figure 5. Marriage registration by place type, Ifugao: 2022

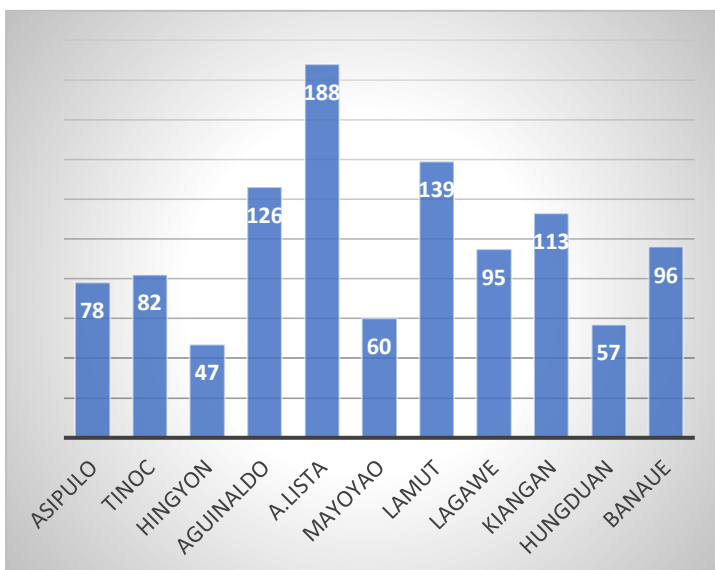
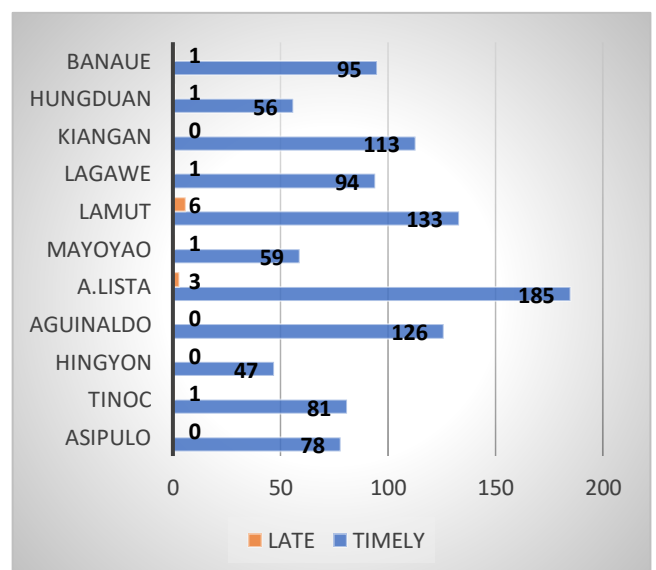
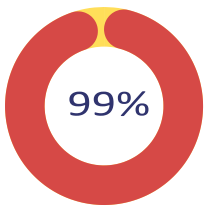


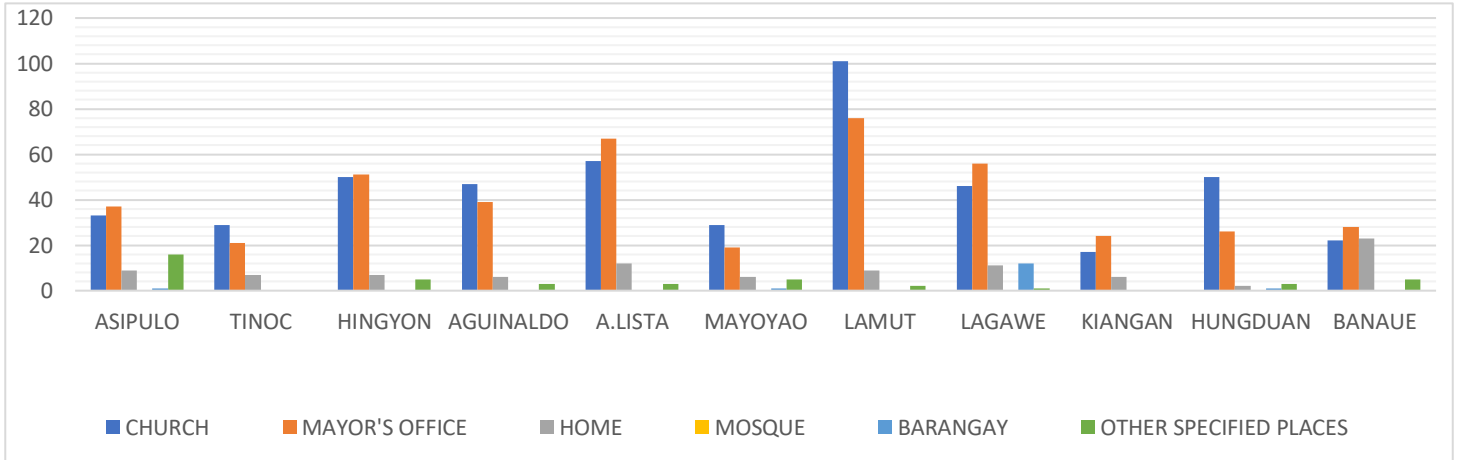
Figure 6. Marriage registration by municipality and by status, Ifugao: 2022



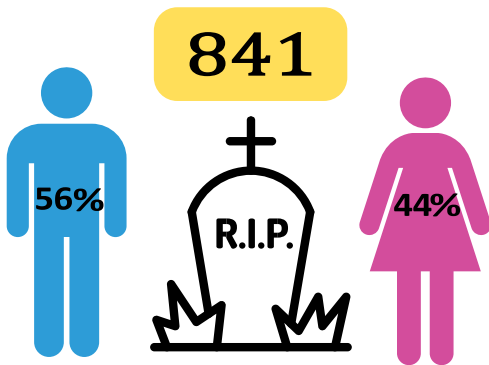


For the status registration, there were 98.7% marriages that were registered on time. For Alfonso Lista, having the highest recorded marriages in the province, only 1% were late registered

DEATH REGISTRATION



More than half of the registered deaths were men. More deaths occurred in Lamut (21%) and Alfonso Lista (19%). It was in Hungduan that recorded the least occurrence of death at 3%.

For the status of registration, Lamut recorded the highest death.

Figure 8. Death Registration by Sex Ifugao: 2022

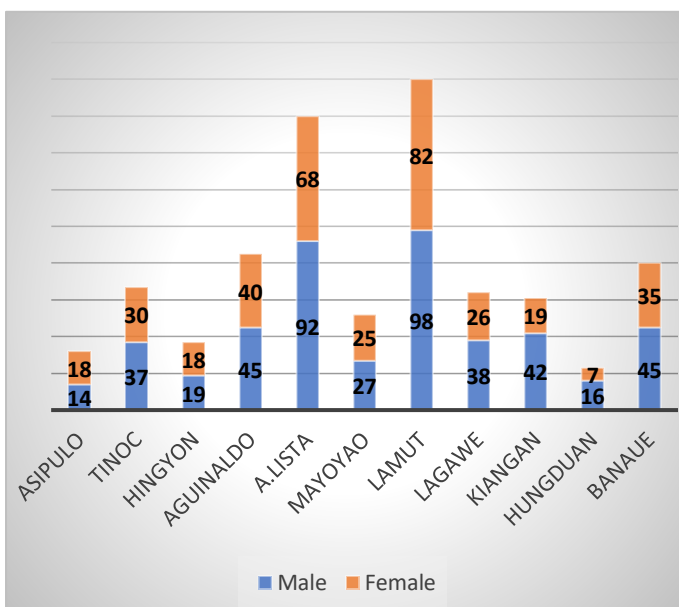


Figure 9. Death Registration by Civil Status, Ifugao: 2022

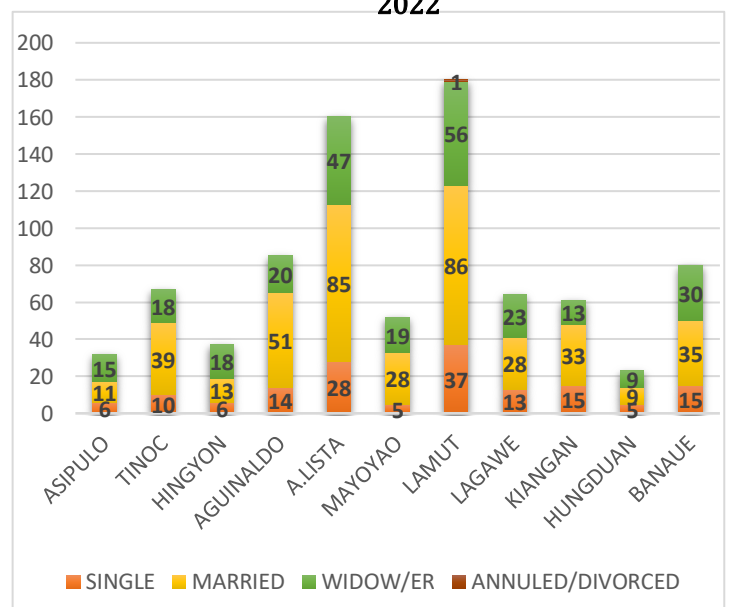


Figure 10. Death registration by municipality and by status: Ifugao, 2022

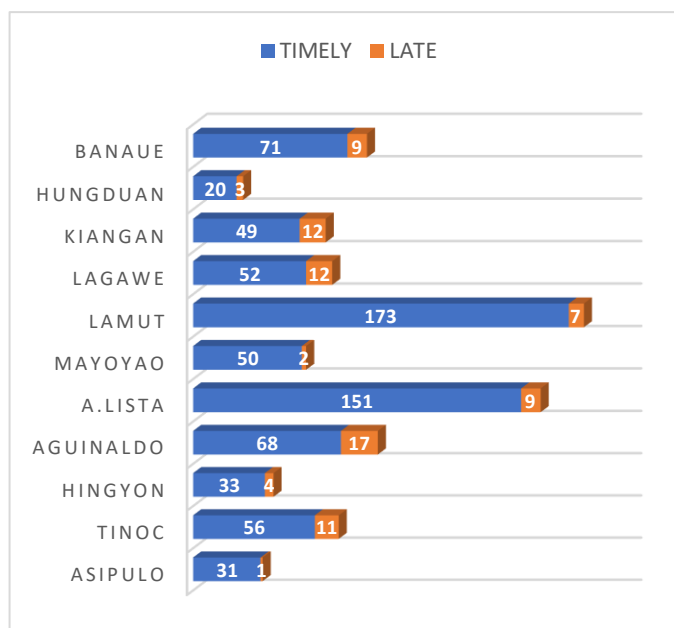
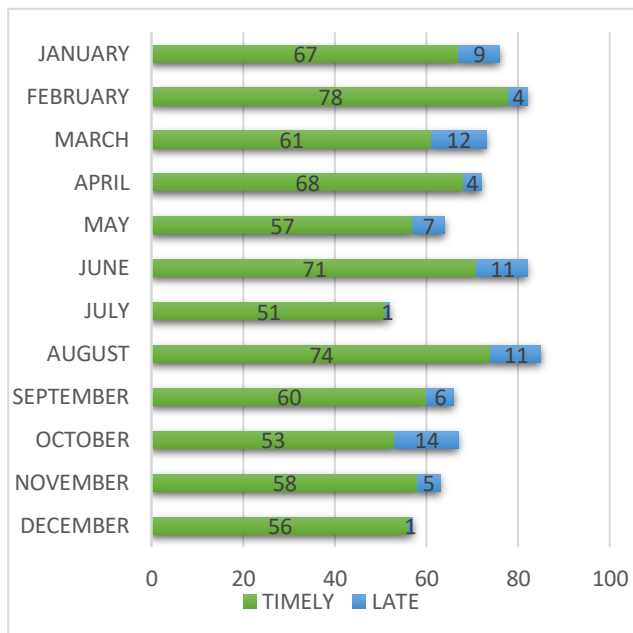


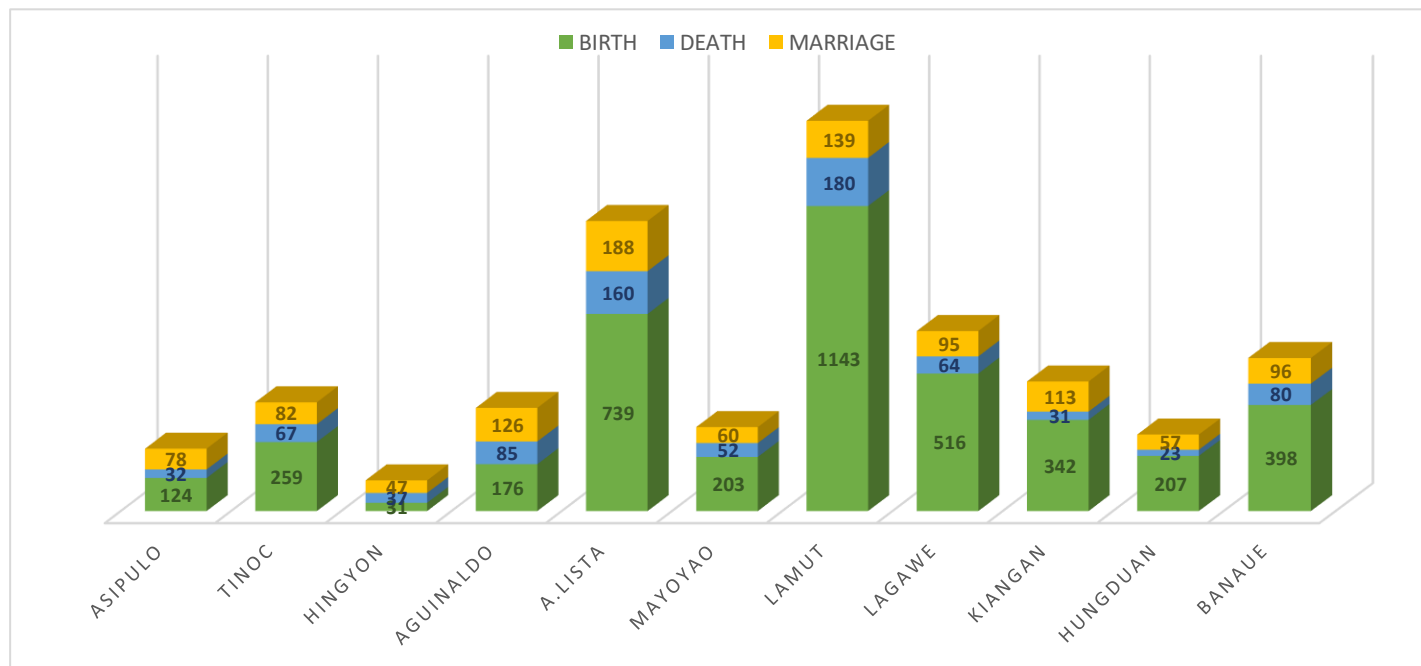
Figure 11. Death registration by status and by month: Ifugao, 2022



For death registration by status and by month, it was in February where more deaths were registered at 20%. More timely deaths were registered also in February and more deaths were late registered in October. July recorded the least registered death at 6.2%.

For the registration of the Birth, Death and Marriage, Lamut got 24.1% of all registered Civil Registry Documents followed by Alfonso Lista with 17.9%. The least number of registered documents was in Hingyon at 2%. Including Foetal Deaths with 18 total recorded and 991 Application for Marriage Licenses, a total of 7,069 registered Civil Registry Documents was recorded for the year 2022.

DEFINITION OF TERMS

Vital Statistics are derived from information obtained at the time when the occurrences of vital events and their characteristics are inscribed in a civil register.

Vital acts and events are the births, deaths, foetal deaths, marriages, and all such events that have something to do with an individual's entrance and departure from life together with the changes in civil status that may occur to a person during his lifetime. Recording of these events in the civil registration and the resulting documents are called vital records.

Municipal Form No. 102 (Certification of Live Birth) is the prescribed form being used for the declaration of facts and circumstances surrounding the birth of a person for purpose of registration.

Municipal Form No. 103 (Certification of Death) is the prescribed form being used for the declaration of facts and circumstances surrounding the death of a person for purposes of registration.

Municipal Form No. 97 (Certification of Marriage) is used to record information pertaining to the marriage of the contracting parties. It contains information regarding the groom and the bride.

Live Birth is a complete expulsion or extraction from its mother of a product of conception, irrespective of the duration of the pregnancy, which after such separation breathes or shows any other evidence of life, such as the beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been cut or the placenta is attached; each product of such a birth is considered live born.

Marriage is a contract of permanent union between a man and a woman entered into in accordance with law for the establishment of conjugal and family life.

Death refers to the permanent disappearance of all evidence of life at any time after live births have taken place (postnatal cessation of vital function without the capability of resuscitation).

Foetal death refers to death prior to the complete expulsion or extraction of a product of conception from its mother, irrespective of the duration of pregnancy.

Legitimate refers to a child conceived or born during a valid marriage of parents.

Illegitimate refers to a child conceived and born outside of a valid marriage of parents.

This release contains statistical tables and graphs encompassing the vital event – births, marriages & deaths occurring in the province of Ifugao.

Data on births, deaths, and marriages presented in this release were obtained from the Certificate of Live Birth (Municipal Form 102), Certificate of Death (Municipal Form 103), and Certificate of Marriage (Municipal Form No. 97) that were registered at the Office of the City/Municipal Civil Registrars and forwarded to the Philippine Statistics Authority Provincial Statistical Offices in Ifugao. Information included births, deaths and marriages registered in January to December 2022.
