2022 VITAL STATISTICS, BENGUET



The vital event in Benguet increased from January - February last year to January - February this year.

The registered certificate of live birth of Benguet increased from January - February last year with 811 documents to 1035 registered Live Birth for the month of January - February 2022.

The registered certificate of marriage increased with 294 documents from 222 January-February 2021 to 516 documents this January – February 2022.

The registered certificate of death registered with almost the same total number of submitted documents with 465 January-February 2021 to 467 this January – February 2022.

Figure 2 Total Number Registered Live Birth



Figure 2 shows the number of registration of certificate of live births for 2021-2022 from January to February in the province of Benguet. The data shows that the total registered certificate of live birth slightly increased by 111 documents from January-February of 2021 with 924 documents compared to January – February 2022 with 1035 documents.

La Trinidad increased by 168 certificate of live birth with 474 documents from January - February 2021 to 642 documents of

January - February 2022. Followed by Mankayan and Tublay with 4 total number of registered certificate of live births each. The next with an increase is the municipality of Sablan with 3 certificate of live birth , Lastly is the municipality of Atok with one increased in the documents submitted from 61 certificate of live birth last January - February 2021 to 62 certificate of live birth in January-February 2022.

Municipality of Buguias decreased by 33 registered certificate of live birth from January - February 2021 with 159 registered certificate of live birth compared to 126 registered certificate of live birth. The second municipality with 21 certificate of live birth decreased is the municipality of Bokod from



61 last January-February 2021 to 40 documents this January-February 2022 of certificate live birth. The third municipality of Tuba with a decreased of 7 certificate of live birth from 19 last January-February 2021 to 12 this January-February 2022.


The municipalities with the same certificate of live birth documents submitted were Kabayan and Kibungan with 12 documents and 29 documents respectively.

Municipalities with increased in Total number of registration from January–February 2021 compared to January–February 2022 are Tuba with a difference of 50 registered certificate of marriage from 36 certificate of marriage to 86 documents, followed by La Trinidad with 44 certificate of marriage in difference and Itogon with 38 documents. The municipalities of Bakun and Mankayan have the same in increased certificate of marriage from January–February 2021 with 11 certificate of Marriage with respect to January–February 2022.

The municipalities with slight registered increase in total of marriage certificate Kibungan with 5 certificates of marriage, Sablan with certificates marriage, of Kapangan and Tublay with 2 certificates of marriage each and Atok certificate with 1 marriage.

The data shows that the total registered certificate of death increase by 109 documents from January–February of 2021 with 379 documents compared to January–February 2022 with 488 documents.

Registered certificate of death were Mankayan with 12 certificate of death from 34 documents in January–February 2021 to 22 certificate of death from January–February 2022, Same is true with Tuba with 12 documents from January–February 2021 with 43 documents to 31 documents in January–February 2022 and lastly the municipality of Kibungan with 1 document decreased from January–



increase are Bokod with 1 document and Kabayan with 2 documents.

The figure shows that the Municipality with the highest submitted registered certificate of Live Birth for January–February 2022 is La Trinidad with 642 documents. It was followed by the municipality of Buguias with 126 certificate.


The municipalities who submitted the lowest certificate of Live Birth in the province is Sablan with 6 followed by the Municipalities of Tuba, Kapangan and Bakun with 12 documents respectively.

MARRIAGE BY MUNICIPALITY

The figure shows the registered certificate of Marriage in the province of Benguet from January-February 2022.

The municipality of La Trinidad registered the highest certificate of Marriage submitted to the provincial office with 126 documents. The municipality of Tuba submitted the 86 certificate of marriage following the municipality of La Trinidad followed by Itogon with 62 documents.

The municipality with the lowest registered certificate of marriage is Kabayan with 12 documents followed by Bokod and Sablan with 14 and 15 respectively.



DEATH BY MUNICIPALITY



The figure shows that the municipality of La Trinidad have the highest registered certificate of Death in the province with 158 documents, followed by municipalities of Buguias and Itogon with 55 and 54 documents respectively.

The lowest registered certificate of death is the municipality of Sablan together with municipality of Bakun with 13 documents followed by Kabayan and Kibungan with 14 and 17 documents respectively.

The municipalities with the same registered certificate of death are Atok and Mankayan with 22 documents.

Technical Notes:

Live Birth- is a complete expulsion or extraction from its mother of a product of conception, irrespective of the duration of the pregnancy, which after such separation, breathes or shows any other evidence of life, such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been cut off or the placenta is still attachedeach product of such a birth is considered alive.

Marriage - is defined as a special contract of permanent union between a man and a woman entered into in accordance with law for the establishment of conjugal and family life. It is the foundation of the family and an inviolable social institution whose nature, consequences, and incidence are governed by law and not subject to stipulation, except that marriage settlements may fix the property relations during the marriage within the limits provided in the Family Code of the Philippines.'

Death - is a permanent disappearance of all evidence of life at any time after live birth has taken place (postnatal cessation of vital functions without capability of resuscitation). (U.N. Statistical Commission).

A fetus with an intra-uterine life of seven (7) months or more and born alive at the time it was completely delivered from the maternal womb but died later shall be considered as death and shall be registered in the Register of Deaths.
