- Government Agencies (NGAs, LGUs, GOCCs, SUCs): Faster and more accurate service delivery, better program targeting, enhanced national security, streamlined business permitting, efficient tax collection, and improved access to community services.
- Employers and Companies: Faster employee onboarding and payroll processing, enhanced workplace security, prevention of illegal employment, secure online transactions, reliable age verification, and improved customer identification.
- Banks and Financial Institutions: Quicker account opening, easier KYC compliance, faster loan processing, stronger transaction security, and improved financial inclusion.
- Schools and Universities: Streamlined student enrollment, secure online learning access, and simplified scholarship or grant applications.
