

REGISTERED VITAL EVENTS IN IFUGAO 2nd Quarter 2020

This report summarizes the data gathered from April to June 2020 documents submitted from the local civil registry offices of the eleven municipalities in the province of Ifugao. The number of vital events in Ifugao for the 2nd semester reached 846 registered documents. This represents 42.68% decreased from the 1,476 registered vital events from the previous semester. An utmost decreased of registration due to COVID-19 pandemic that place Luzon, NCR and other provinces in Visayas and Mindanao in Enhanced Community Quarantine (ECQ). Some municipality have no recorded vital events due to suspended transactions during ECQ. The province generated the following statistics: 633 for birth, 44 for marriage and 169 for death.

In this April to June 2020 issue, the Philippine Statistics Authority of Ifugao presents the number of births, marriages, and deaths registered by municipalities in the province. The data are preliminary result from the Decentralized Vital Statistics System 2011 based on the documents submitted by the Local Civil Registry Offices in Ifugao.

EXPLANATORY NOTES

VITAL STATISTICS are derived from the information obtained at the time when the occurrences of vital events and their characteristics are inscribed in civil register.

Vital acts and events are the births, deaths, foetal deaths, marriages, and all events such that have something to do with an individual's entrance and departure from life together with the changes in civil status that may occur to a person during his lifetime. Recording of these events in the civil register is known as vital or civil registration and the resulting documents are called vital records.

Data on vital statistics presented in the release were obtained from the documents registered at the Office the City/ Municipal Civil Registrars all throughout the country and forwarded to the Philippine Statistics Authority.

BIRTH STATISTICS


Registered live births decreased by 32.01 percent

The number of registered live births in the province of Ifugao in the 2nd semester 2020 totalled to 633, lower by 32.01 percent from 931 registered live births in the 1st semester 2020.

Lamut top registered live births in the 2nd quarter 2020

Among the 11 municipalities in the province, Lamut recorded the most number of births in the province of Ifugao for the 2nd quarter of 2020 with 204, lower by 40 percent from 340 total registered births in the 1st quarter 2020. Lamut is the location of the government hospital in Ifugao which is the Panopdopan District Hospital, hence, a high number of registered births were recorded. Other municipalities with high number of registered births are Alfonso Lista with 106 births, also with a district hospital and distantly behind are Tinoc with 66, Aguinaldo with 54 and Banaue with 47 births.

Meanwhile, the municipality of Hingyon with 4 or 0.63 percent of the total registered births had reported the least number of births in the province.





MOST BABIES WERE BORN OF MARRIED MOTHERS


In the 2nd semester of 2020, out of 633 registered live births in the province there were about 64.93 percent or 411 births were legitimate, lower by 29.86 from 586 total registered births in the 1st semester. Only 35.07 percent or 222 births were born out of wedlock, lower by 35.65 percent from 345 registered live births in the 1st semester 2020.

MORE MALES WERE BORN THAN FEMALES

Registered births for males have 337 births or 53.24 percent, lower by 32.60 from 500 registered males in the 1st semester. Registered births for females have 296 births or 46.76 percent for females, lower by 31.32 from 431 total registered births foe females in the 1st semester.

MOST BIRTHS WERE REGISTERED ON TIME

Out of 633 registered births in the province, there were about 88.63 percent or 561 births registered on time, and only 11.37 percent or 72 births were registered late.





MARRIAGE STATISTICS

Alfonso Lista recorded the highest registered marriages for the 2nd quarter 2020

In the 2nd quarter of 2020, a total of 44 registered marriages occurred in the province of Ifugao, lower by 87.64 percent from the 356 registered marriages in the 1st semester of 2020. The decreased was due to the implementation of ECQ in the province that limit gatherings and celebrations to observe social/ physical distancing as a protocol to IATF guidelines.

Alfonso Lista still remained the the highest number of registered marriages with 18 couples which comprised of 40.91 percent of the total marriage registered. It was followed by Banaue with 5 marriages which comprised 11.36 percent of the total registered marriages in the province. Then, Aguinaldo, Asipulo, Hungduan, Lagawe and Tinoc both with 3 or 6.82 percent of the total registered marriages. On the other hand, Hingyon and Kiangan posted the lowest with only 1 or 2.27 percent of the registered couples.



DEATH STATISTICS

Alfonso Lista recorded the highest registered deaths for the 2nd quarter 2020

A total of 169 deaths recorded in the province of Ifugao for the 2nd quarter of 2020, lower by 10.58 percent from 189 registered deaths of the 1st semester 2020. The highest death occurrences happened in the municipality of Alfonso Lista with 44 deaths which comprised 26.04 percent of the total number of deaths. Lamut registered 31 deaths which comprised 18.34 percent of the total registered deaths. Trailing behind are Tinoc with 17, Aguinaldo and Lagawe with 16 registered deaths respectively.


Meanwhile, Hingyon is lagged behind at the bottom track with 3 registered deaths or 1.78 percent.

MORE MALES DIED THAN FEMALES


In the 2nd quarter of 2020, there were about 95 or 56.21 percent registered deaths for males and only 74 or 43.79 percent for females. This indicates that more males had died than female.

MOST DEATHS WERE REGISTERED ON TIME

In the 2nd quarter of 2020, out of 169 registered deaths in the province there were about 78.70 percent or 133 deaths were registered on time and only 21.30 percent or 36 deaths were registered late.



237 DOCUMENTS OR 28.01 PERCENT OF THE TOTAL DOCUMENTS WAS FROM THE MUNICIPALITY OF LAMUT


The province of Ifugao received a total of 846 registered documents for the 2nd quarter of 2020, lower by 42.68 from 1, 476 total registered documents of the 1st semester 2020. The municipality of Lamut has the highest documents received with a total of 237 or 28.01 percent, lower by 42.34 from 411 of the total documents in the 1st semester 2020. It was followed by the municipalities of Alfonso Lista with 168 or 19.86 of the total documents. Distanly behind are Tinoc with 86, Aguinaldo with 73 and Banaue with 62. Meanwhile, the least municipality received was Hingyon with only 8, lower by 85.19 from 54 total documents in the previous semester.

346 DOCUMENTS OR 40.90 PERCENT OF THE TOTAL DOCUMENTS WAS FROM THE MONTH OF JUNE

Of the 846 registered documents received in the province for the 2nd quarter 2020, 346 or 40.90 percent were recorded in June. On the other hand, the month of April recorded the least with 220 documents or 26.01 percent.

Definition of Terms

VITAL STATISTICS are derived from information obtained at the time when the occurrences of vital events and their characteristics are inscribed in a civil register.

MUNICIPAL FORM NO. 102 (CERTIFICATION OF LIVE BIRTH) is the prescribed form being used for the declaration of facts and circumstances surrounding the birth of a person for purpose of registration.

MUNICIPAL FORM No. 103 (CERTIFICATION OF DEATH) is the prescribed form being used for the declaration of facts and circumstances surrounding the death of a person for purposes of registration.

MUNICIPAL FORM NO. 97 (CERTIFICATION OF MARRIAGE) is used to record information pertaining to the marriage of the contracting parties. It contains information regarding the groom and the bride.

LIVE BIRTH is a complete expulsion or extraction from its mother of a product of conception, irrespective of the duration of the pregnancy, which after such separation breathes or shows any other evidence of life, such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been cut or the placenta is attached; each product of such a birth is considered liveborn.

MARRIAGE is contract of permanent union between man and a woman entered into in accordance with law for the establishment of conjugal and family life.

DEATH refers to the permanent disappearance of all evidence of life at any time after live births has taken place (postnatal cessation of vital function without capability of resuscitation).
