# VITAL EVENTS FIRST QUARTER 2023 MUNICIPALITY OF MAYOYAO

Date of release: 09 June 2023 Reference No. SR-2023-023

This special release presents statistics on vital events occurring for the first quarter of 2023 in the municipality of Mayoyao, Ifugao. This publication shows the total registered birth, marriage, and death statistics by registration status, sex, legitimacy status, age, type of ceremony, and place type. The civil registry documents transmitted monthly by the Local Civil Registry Office (LCRO)-Mayoyao to Ifugao Provincial Statistical Office for machine processing served as the source of data in preparation of this special release.

#### **BIRTH REGISTRATION**



Live birth is defined as complete expulsion or extraction from its mother of a product of conception, irrespective of the duration of the pregnancy, which after such separation, breathes or shows any other evidence of life, such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been cut or the placenta is attached, each product of such a birth is considered live born.

Table 1 shows that a total of 58 live births were registered in the municipality of Mayoyao for the first quarter of 2023. The month of January recorded the most at 38% live births. It was followed by the month of March and February with 33% and 29%, respectively. By sex disaggregation, male births had a higher registered number at 52% than female births who recorded 48%.

In table 2, it, shows that there was more late registration (64%) than timely registered births (36%). Moreover, there were 81% legitimate babies and 19% were illegitimate babies. Legitimate babies were higher by 36. Therefore, more babies were born of wedlock.



In the figure below, it shows that there were more babies born at home (83%) than babies born in the hospital (17%). There was no record of registration on other places.

#### MARRIAGE REGISTRATION



Marriage is defined as a contract of permanent union between a man and a woman entered into in accordance with law for the establishment of conjugal and family life. It is the foundation of the family and an inviolable social institution whose nature, consequences, and incidence are governed by law and not subject to stipulation, except that marriage settlements may fix the property relations during the marriage within the limits provided in the Family Code of the Philippines.

In the first quarter, a total of 34 marriages were registered in the municipality of Mayoyao. The month of February recorded the most at 82% marriages. It was followed by the month of March and January with 12% and 6%, respectively.


Table 3 shows that most of the registered marriages were recorded timely within the reglementary period of 30 days.


FIGURE 2. Total Registered Marriages by Type of Ceremony, Mayoyao: 1st Quarter 2023

In figure 2, it shows that weddings conducted by civil wedding rites had the highest registered marriages at 67%, followed by other religious rites and Roman Catholic at 24% and 9%, respectively.

In the table below, it shows that among the place types for marriage, weddings held at other specified places had the highest number of registered marriages at 59%, followed by church, mayor's office and home, with 29%, 9% and 3%, respectively. There was no occurrence of marriage registration at the barangay hall.

### **DEATH REGISTRATION**



Death refers to the permanent disappearance of all evidence of life at any time after live birth has taken place (postnatal cessation of vital function without capability of resuscitation).

In the first quarter, a total of 15 deaths were registered in the municipality of Mayoyao. The month of March recorded the most deaths with 47%. It was followed by the month of January and February at 33% and 20%, respectively.

Table 4 shows that by sex disaggregation, there were more male deaths registered (53%) than female deaths registered (47%).

Table 5 shows that by civil status, deaths with widow/widower and married status were both at 40% and singles with 20%. Moreover, majority of the deaths registered were recorded within the reglementary period of 30 days.
