

Contract Agreement Form

THIS AGREEMENT made the 27th day of December, 2023 between **PHILIPPINE STATISTICS AUTHORITY CAR** of the Philippines located at 3/F CTLL Building, 141 Abanao Extension, Baguio City (hereinafter called "the Entity") of the part and **MCKLEENE Premium Products, Inc.** of No. 16 General Luna Street, City of San Fernando, La Union (hereinafter called "the Supplier") of the other part.

WHEREAS the Entity invited Bids for certain goods and ancillary services, viz., **Provision of Janitorial Services for Philippine Statistics Authority-Cordillera Administrative Region Office** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Three Million Ninety One Thousand One Hundred Fourteen Pesos and Sixty-Nine Centavos (Php 3,091,114.69)** (VAT inclusive) for One (1) year (January 1, 2024 to December 31, 2024) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental of Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all the other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents of information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Three Million Ninety One Thousand One Hundred Fourteen Pesos and Sixty-Nine Centavos (Php 3,091,114.69)** or such other sums as may be ascertained, **MCKLEENE Premium Products, Inc.** agrees to deliver Janitorial Services for **Philippine Statistics Authority- Cordillera Administrative Region** in accordance with his/her/its Bid.
4. The **PHILIPPINE STATISTICS AUTHORITY CAR** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


