PhilSys Launches New Services: Updating of Demographic Information and Digital National ID Now Available

In line with Section 11 of Republic Act No. 11055, otherwise known as Philippine Identification system (PhilSys) Act, all registered persons are required to update the necessary information in case of change in or correction of entry/ies in the information collected and stored under the PhilSys. Pertinent thereto, the Philippine Statistics Authority (PSA) has fully implemented the availability of updating services to the general public.

Currently, only changes of entry or entries on the demographic information are available, including corrections that may affect a person's nationality, age, status, or filiation. This also encompasses the correction of clerical or typographical errors, which are minor mistakes such as misspelled names or incorrect places of birth. Additionally, if it is evident that these entries contain clerical or typographical errors, the office permits changes to the first name or adjustments to the day and/or month of the birthdate.

The registered individual is advised to personally appear at the PSA Kalinga Fixed Registration Center to process his/her request. Along with the necessary supporting documents, the registered person must bring his/her PhilID or ePhilID. If the PhilID is misplaced or lost, the registered person must submit an affidavit of loss, which can be either notarized or non-notarized. In the event of a lost ePhilID, the registered person shall request the issuance of his/her replacement of ePhilID. The supporting documents for the updating service can be accessed through:

Through the collaborative efforts of the PSA, Office of the Special Assistant to the President for Investment and Economic Affairs (OSAPIEA) and the Department of Information and Communications Technology (DICT), Digital National ID was launched to foster seamless service delivery and enhance ease of doing transaction with government and private institution subject to authentication.

As part of this initiative, PhilSys registered individuals can generate the Digital National ID through <https://national-id.gov.ph/> or through eGov PH application. Registered individuals may also take a screenshot of the Digital National ID to obtain a personal copy. The 7-easy steps to generate Digital National ID are the following:

1. Open the internet browser and type in the website <https://national-id.gov.ph>
2. Click the "Proceed" button to provide "Consent" to PSA to use your demographic information and facial image to authenticate.
3. In the designated fields, type your First Name, Middle Name, Last Name, and Date of Birth.
4. Scroll down and click the "Continue" button.
5. Click on the "Start Liveness" button to begin the facial authentication.

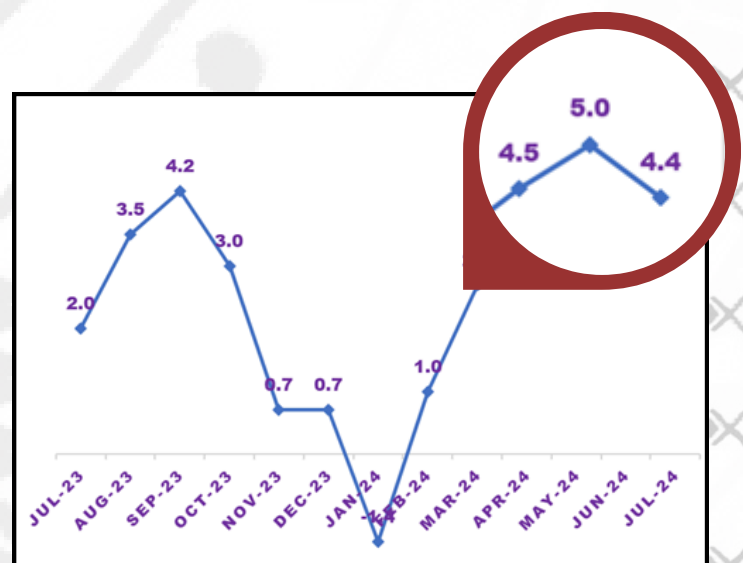
6. Once verified, you can now proceed to view your Digital National ID by clicking on the "View National ID" button.

7. Click on the "Download Digital ID" button to obtain a personal copy of your Digital National ID.

To verify the authenticity of the Digital National ID, the National ID check could be used by all interested relying parties (RP). The use of the website is now available and free of charge. The website allows users to verify and authenticate the Digital National ID by scanning its QR code. The said website could be accessed through <https://everify.gov.ph>.

The RPs were strongly encouraged to apply for the National ID Authentication Services with the PSA for higher assurance of verification. The National ID Check marked a major advance in the country's digitalization efforts, enhancing efficiency, security, and transparency in transactions across different sectors.

The Headline Inflation rate in Kalinga goes down to 4.4 percent in July 2024, from 5.0 percent in June 2024. In June 2023, inflation rate was observed at 2.0 percent.

In the month-on-month comparison, the Consumer Price Index (CPI) in All Items is posted at -0.2 percent lower from 127.3 to 127.0. The decrease on the monthly CPI of the month was the result of the decrease of prices from the group of Alcoholic Beverages and Tobacco with -0.9 percent change from 186.0 to 184.3, Food and Non-Alcoholic beverages with -0.4 percent change from 129.7 to 129.2, Housing, Water, Electricity, Gas and other Fuels and Restaurant and Accommodation Services with -0.2 percent change from 110.2 to 110.0, Personal Care and Miscellaneous Goods and Services with -0.1 percent change from 123.8 to 123.7, and lastly the Clothing and Footwear with the same -0.1 percent change from 129.5 to 129.4. Health from 139.9 to 140.0, and then from the following group with the same 0.1 percent increase; 0 and lastly with.

Moreover, there was an increase in percent change in the group of Transport with 0.5 percent change from 120.6 to 121.2, Recreation and Culture with 0.3 percent change from 119.6 to 120.0, and the group of Furnishings, Household Equipment and Routine Household maintenance and Health with the same 0.1 percent increase from 136.5 to 136.7 and 140.0 to 140.1 respectively.

Meanwhile, stable consumer price index registered in the following items; Financial Services with 146.0; Restaurant and Accommodation Services with 147.7 and Education services with 127.7, and Information and Communication with 103.3 to 103.4.

The Purchasing Power of Peso (PPP) in Kalinga was valued at 0.79 this July 2024, 3 centavos lower than the PPP of July 2023 with 0.82 centavos.



Kalinga Vital Statistics: 2024 Second Quarter

The number of registered births in the province of Kalinga for the second quarter of 2024 summed up to 1,511. The City of Tabuk has the highest birth registered with 933 birth occurrences or 61.75% of the total registered births for the 2nd quarter 2024. The Municipality of Pasil recorded the least number of documented births with 19 birth occurrences followed by the municipality of Tanudan with 27 birth occurrences.

For registered marriages, it summed up to 286 which is lower by 1 compared to last quarter with 287. The City of Tabuk has the highest marriage registered with 128 marriage occurrences or 44.76% of the total registered marriages for the 2nd quarter 2024. The municipalities of Pasil and Lubuagan recorded the least number of documented marriages with 3 and 7 marriage occurrences respectively in the 2nd quarter 2024.

Moreover, the number of registered deaths for the second quarter of 2024 summed up to 309. The City of Tabuk has the highest death registered with 218 death occurrences or 70.55% of the total registered. The municipalities of Lubuagan and Balbalan recorded the least number of documented deaths with only 6 and 8 death occurrences respectively followed by the municipalities of Tanudan and Tinglayan with 9 death occurrences.
