PSA IFUGAO INTRODUCES THE NEW SERVICES OF PHILSYS

Lagawe, Ifugao – The Philippine Statistics Authority (PSA) – Ifugao is excited to announce the launch of several new services under the Philippine Identification System (PhilSys), designed to enhance accessibility and improve the user experience for all citizens.

Digital National ID

On June 10, 2024, the PSA officially rolled out the Digital National ID, marking a significant step towards modernizing and streamlining identification processes in the Philippines. In a public advisory dated June 11, 2024, the PSA informed the public, as well as government and private institutions, that the Digital National ID is a valid and sufficient proof of identity. It can be verified using the National ID check. Citizens can access their Digital National ID online at the official website: http://national-id.gov.ph. Verification can be performed through the National ID check at http://everify.gov.ph.

Updating of Demographic Information



In accordance with Section 11 of Republic Act No. 11055, known as the Philippine Identification System (PhilSys) Act, all registered persons are required to update any necessary information in the event of changes or corrections to their data collected and stored under PhilSys. The PSA has fully implemented the availability of updating services for the general public.

Currently, the updating service covers changes or corrections in demographic information, including adjustments affecting nationality, age, marital status, or filiation. This also includes corrections for clerical or typographical errors, such as misspelled names or incorrect places of birth. Moreover, if clerical or typographical errors are evident, the PSA allows for changes to first names or adjustments to the day and/or month of the birthdate.

PSA Ifugao encourages all residents to take advantage of these new services and to stay informed about further updates related to PhilSys.

JUNE 2024 PRICE INDICES IN IFUGAO

Inflation in Ifugao increased to 5.9 percent in June 2024 from 5.7 percent in May 2024. In addition, June 2024 inflation was higher by 2.7 percentage points from 3.2 percent in June 2023 and 0.2 percentage points lower from 5.7 percent in May 2024.


In terms of inflation rates among commodity groups, Food and Non-Alcoholic Beverages experienced the highest increase at 11.3 percent. Following closely behind, Education Services recorded a 6.9 percent inflation rate and Clothing and Footwear with 3.7 percent.

The Survey of Retail Prices of Commodities, conducted by the Philippine Statistics Authority (PSA), has produced a Consumer Price Index (CPI) of 127.1 in Ifugao as of June 2024, with 2018 serving as the base year. This figure indicates that the overall cost of a typical basket of goods and services commonly purchased by a Filipino household in various municipalities of Ifugao remained stable during the reference month.

The Purchasing Power of the Peso (PPP) is intricately tied to the Inflation Rate, albeit in an inverse manner. As the Inflation Rate rises, the PPP declines. To illustrate, consider 1 peso in 2018: in June 2024, its value dwindles to 79 centavos, marking a decrease of 4 centavos from June 2023 when it stood at 83 centavos. Similarly, a hundred pesos from 2018 would translate to just 79 pesos by June 2024.

This consistent drop in the purchasing power of peso underscores the profound impact of inflation on consumers. With the diminishing purchasing power of the peso, maintaining the usual standard of living and managing expenses becomes increasingly challenging.

A decline in the purchasing power of the peso implies that each peso can procure fewer goods and services than before.

OpenSTAT is an open data platform powered by PC-Axis, a user-friendly application for presenting statistical data and metadata coupled with API and visualization features. This system allows the PSA to share data under an open data license where data can be freely used, re-used, and redistributed by anyone without any restrictions other than proper source attribution.

PSA IFUGAO CONDUCTS 2ND LEVEL TRAINING FOR 2024 CENSUS OF POPULATION AND COMMUNITY-BASED MONITORING SYSTEM

Lagawe, Ifugao – In preparation for the implementation of the 2024 Census of Population and Community-Based Monitoring System (POPCEN-CBMS), the Philippine Statistics Authority (PSA) Ifugao held a comprehensive 2nd Level Training from June 19-21 and June 24-26, 2024. The training took place at the PSA Conference Hall, G/F RTK Building, Poblacion South in Lagawe, Ifugao and involved 11 Census Area Supervisors and six Head Census Area Supervisors.

This essential training aimed to ensure a uniform understanding of POPCEN-CBMS concepts, operational definitions, and procedures among field personnel before the actual enumeration process begins.

Following this provincial-level training, municipal-level training is scheduled to commence on July 8-13, 2024. This session will engage 223 Enumerators and 37 Team Supervisors in Ifugao, further enhancing the capacity and readiness of the teams involved in the census.

The 2024 POPCEN-CBMS is a vital nationwide initiative designed to update the population inventory of the Philippines while improving the social registries of both national government agencies and local government units (LGUs).



The **PhilSys Check** is developed for PhilSys relying parties and the public to authenticate a PhilID and ePhilID holder's identification easier and faster.

Through this site, visitors can verify information contained in the QR code found at the back of a PhilID card

If you need a copy of a PSA birth, marriage, or death certificate or a CENOMAR, you can easily order for it online at PSAHelpline.ph and have the document delivered to you. You also have the option to visit a PSA outlet and personally request for it over the counter. This works best for individuals who are requesting the civil registry documents of relatives and friends as online ordering is available only when you are requesting PSA certificates for yourself, your children, or your parents.
