Republic Act No. 8425 of 1997 (Social Reform & Poverty Alleviation Act)

Poor refers to "Individuals and families whose income fall below the poverty threshold as defined by the National Economic and Development Authority (NEDA) and/or cannot afford in a sustained manner to provide their minimum basic needs of food, health, education, housing and other essential amenities of life." (Section 3 of the RA No. 8425).

The Poverty Statistics was computed using: Income from FIES and Price data from PSA; and Food bundle designed by FNRI

POVERTY THRESHOLD

is the minimum income required for a family or individual to meet the basic food and non-food needs. It is also known as the **POVERTY LINE**.

POVERTY INCIDENCE

is the proportion of families or individuals with income less than the Poverty Threshold to the total number of families or individuals

FOOD THRESHOLD

is the minimum income required for a family or individual to meet the basic food needs, which satisfy the nutritional requirements for economically necessary and socially desirable physical activities.

SUBSISTENCE INCIDENCE

is the proportion of families or individuals with per capita income less than the per capita Food Threshold to the total number of families or individuals.
